

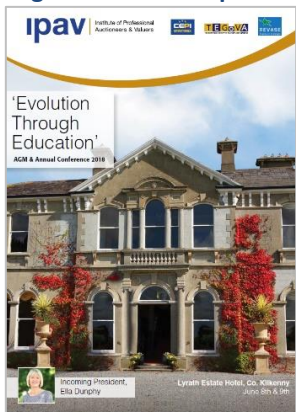
IPAV's New Level 7 Bachelor of Business in Real Estate
