Thank you to IPAV members who met at the Dáil on Tuesday 3rd September to impress upon pubic representatives the urgency of passing the Seller's Legal Pack for Property Buyers' Bill 2021. Collectively, 139 submissions from local to national agents from every county in Ireland were handed in to Leinster House urging the Government and public representatives to ensure the Bill is passed without further delay.

We sincerely thank all members, non-members, agents and stakeholders for continuing to support this Bill, that will revolutionise the sales and conveyancing process.

Importantly, this Collective Submission is a live document, and is being updated with additional
