



IPAV's sustainability advisor, Eamonn Galvin highlights the Challenges with Retrofitting: The 2025 Programme for Government commits to retrofit 500,000 homes to a B2 BER rating by 2030, with accelerated annual retrofitting targets (63,444 homes/year from 2026). This will be challenging as to date only 55,893 homes to a B2 BER rating or higher since the retrofit targets were introduced in 2020. Some of the challenges include high upfront costs, older building stock and labour shortages.

SEAI Home Energy Upgrade Loan Scheme

7 credit union groups (with 28 branches) have joined the Home Energy Upgrade Loan Scheme, with rates starting from 2.99% (depending on the lender). In addition to the seven credit unions groups, the Home Energy Upgrade Loan Scheme is already available from PTSB, AIB, Bank of Ireland and Avant Money in partnership with An Post. The scheme works hand-in-hand with SEAI grant programmes, and loans can be used for a broad range of home energy upgrades.
