Positive changes to First Home Scheme Application Process



Following a regular review to improve customer experience, the FHS are introducing some changes to its application process for customers. The change to the process will now result in customers being issued with an 'Preliminary Certificate'. This precedes the 'Eligibility Certificate' and is similar to the 'AIP' (Approval in Principle) issued by lenders. Like the 'AIP', the 'Preliminary Certificate' will not guarantee funds, but indicates the potential equity funding available once the application process is completed and all necessary documents are provided.

The advantage of this additional step is that it will facilitate customers in 'shopping around' for a property by allowing them to change the key property details on the FHS self-service portal and instantly generate a revised 'Preliminary Certificate' 24/7 without having to contact the FHS directly. The new changes are effective from Monday the 28th of July. Any queries relating to this change or any other aspect of the FHS should be directed to the Brokers/Agents Help Line on 0818 300062.




